This guide is intended to help staff from Commonwealth agencies quickly locate Australian Public Service information on legislative topics and issues. Some of the information referenced in this guide may be of an introductory nature and may not be comprehensive.

The legislative topics and issues referenced in this guide are grouped below under the headings 'measure development', 'drafting process', 'post introduction or making' and 'other'. These headings broadly reflect the stages of a legislative measure. Depending on the particular measure, certain topics and issues may be relevant to more than one stage. To help ensure measures progress effectively, many of the topics and issues should generally be considered early in a measure, even where the topics and issues may directly relate to the later stages of the measure.
